“Is This Goodbye?” iPad Mini Drawing Rules

1. Eligibility

Is This Goodbye? (the Drawing) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Embroidery Network Incorporated dba National Network of Embroidery Professionals and other companies associated with the promotion of the Drawing, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. 4. Drawing Period

Entries that are submitted before or after the Drawing Period will be disqualified. Submissions will be accepted for the duration of the Drawing using any of the following methods: Online.

5. How to Enter

Online: This method of entry will be available by visiting our website (<http://nnepp.com/green>) and following the directions provided to fill out the entry information and submitting it. Entrants must enter their first name, last name and email address to be eligible for the Drawing.

Limit one (1) entry per person, per email address, and per household for the duration of the Drawing Period, regardless of method of entry. 6. Prize Drawing

If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email. Each potential Grand Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize.
